LETTER of AUTHORISATION

[Authorization for Collection Center of E-waste]

2. M/s. National Traders is hereby granted an authorization for Collection Center activity of E-waste under E-Waste (Management & Handling) Rules, 2011 at address Sr. No.103/1/2, Autade, Handewadi Road, Tal. Haveli, Dist. Pune

4. The authorization is hereby granted for Collection Center activity for collection/storage of the E-Waste – 12 MT/A, under the E-Waste (Management & Handling) Rules, 2011 only.

5. The Authorization shall be in force a period of Five Years from the date of issue.

6. The authorization is subject to the conditions stated below and sub conditions as may be specified in the rules in force under the Environment (Protection) Act, 1986.

6. The authorized collection center shall ensure that e-waste collected by them is stored in a secured manner till it is sent to the registered dismantler (s) or recycler (S) as the case may be.

7. The authorized collection center shall ensure that no damage is cause to environment during storage & transportation of E-Waste.

8. They shall submit annual returns in Form 3, to Maharashtra Pollution Control Board on or before the 30th day of June following the financial year to which that returns relates.

9. They shall maintain records of e-waste handled in form 2 and make such records available for scrutiny by Maharashtra Pollution Control Board.


10. The authorized collection center shall obtain an authorization in accordance with procedure under rule 9 from Maharashtra Pollution Control Board & provide details such as address, telephone numbers /helpline number, e-mail etc. of such collection center to the general public.



- General Terms & Conditions of the Authorization:

1. The authorization shall comply with provisions of the Environment (Protection) Act, 1986 and the Rules made there under.
2. The authorization or its renewal shall be produced for inspection at the request of an officer authorized by the Maharashtra Pollution Control Board.
3. The person authorized shall not rent, lend, sell, transfer or otherwise transport the hazardous wastes without obtaining prior permission of the Maharashtra Pollution Control Board.
4. Any unauthorized change in personnel or working conditions as mentioned in the application by the person authorized shall constitute a breach of the authorization.
5. It is the duty of the authorized person to take prior permission of the Maharashtra Pollution Control Board to close down the facility.
6. An application for the renewal of authorization shall be made as laid down in sub -rule (6) of rule of 9 the E-Waste (Management & Handling) Rules, 2011.
7. The Board reserves right to cancel/ Amend/Revoke the authorization at any time as per the Policy of the Board / Government.
